### **BURIAL GROUND CHARGES - NOTES**

#### Non-Angus resident charges will apply as follows:

#### Purchase of Lairs -

Exhumentions

1/ Where the lairholder has lived in Angus for the majority of their life they would retain resident status

2/ Where the lairholder was resident and moved out of the area for care or medical reasons within their final 5 years they would retain resident status

#### Interments –

1/ Where the lairholder has lived in Angus for the majority of their life they would retain resident status

2/ Where the lairholder was resident and moved out of the area for care or medical reasons within their final 5 years they would retain resident status

## In every case the onus will be on the Funeral Director to state resident status on application and provide sufficient evidence of status, should this be required

#### \*Perpetuities/Upkeep of Ground

Perpetuity Fee is a one-off charge to cover maintenance and upkeep of lair. The fee will be applied from 1 April 2017 as follows:

Sale of Lairs – at time of purchase.

Pre-Purchased Lairs – at time of opening ground for first interment after this date.
